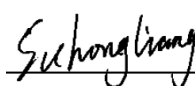

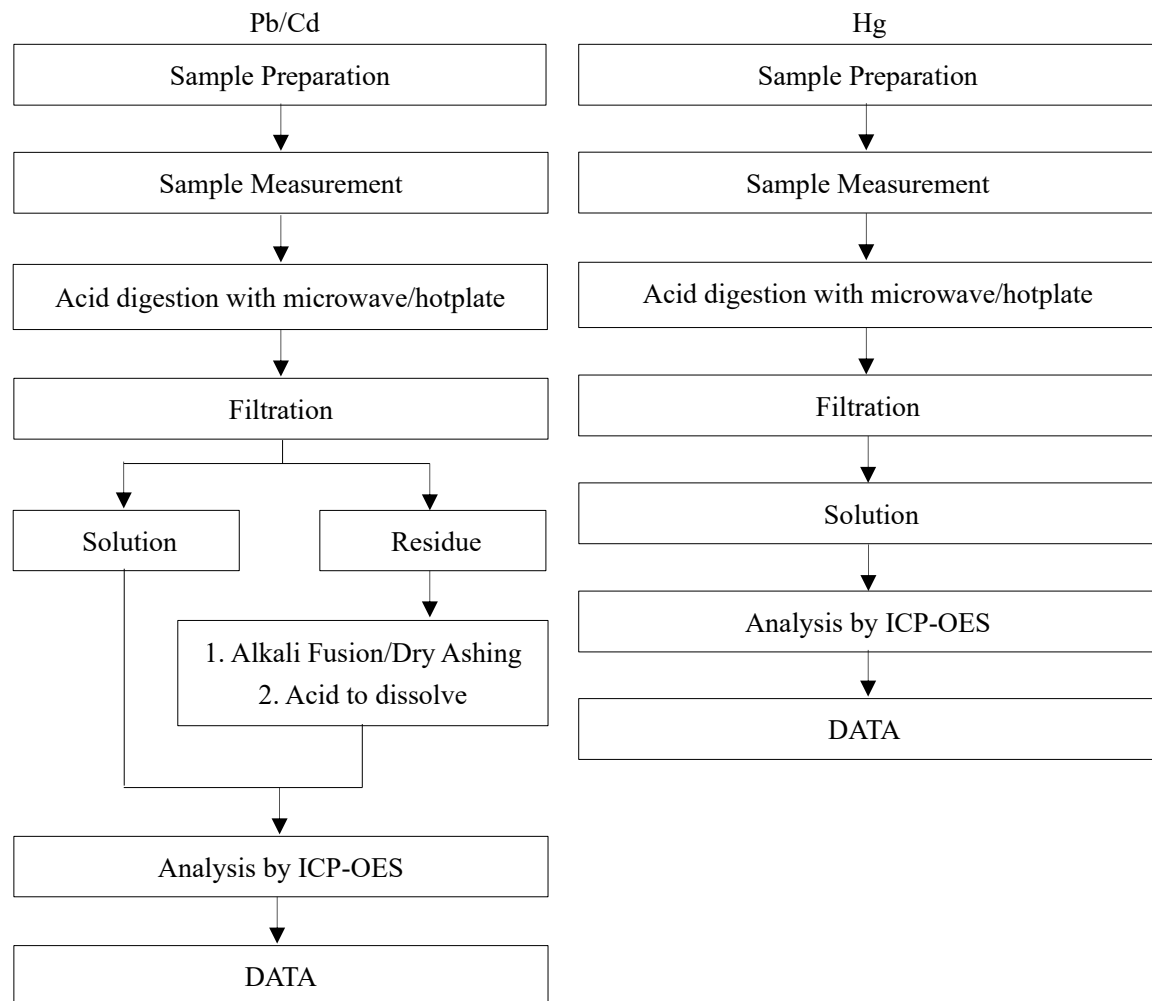

Test Flow Chart of Lead, Cadmium and Mercury



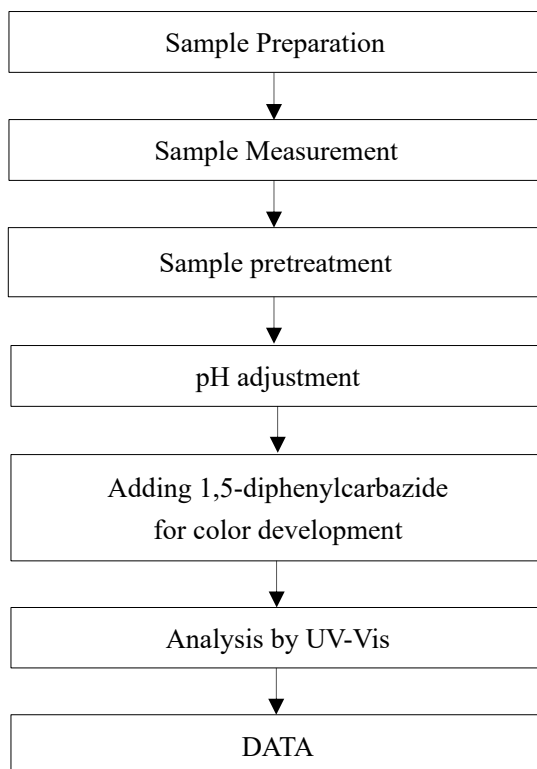
