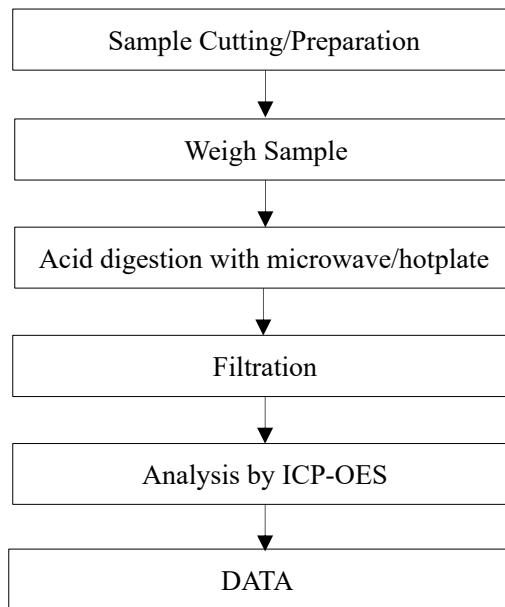
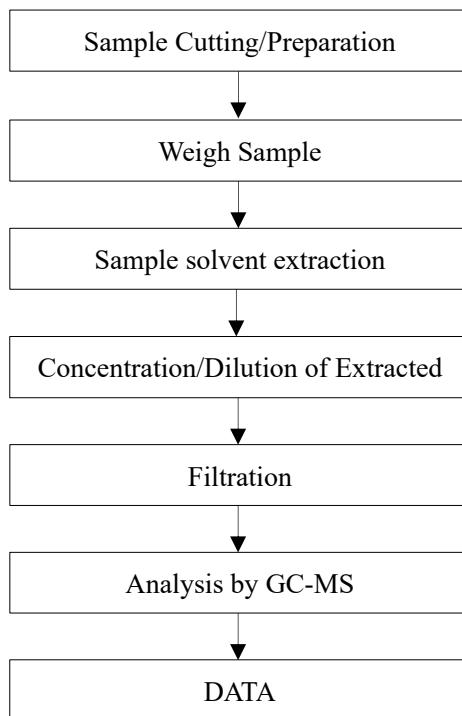

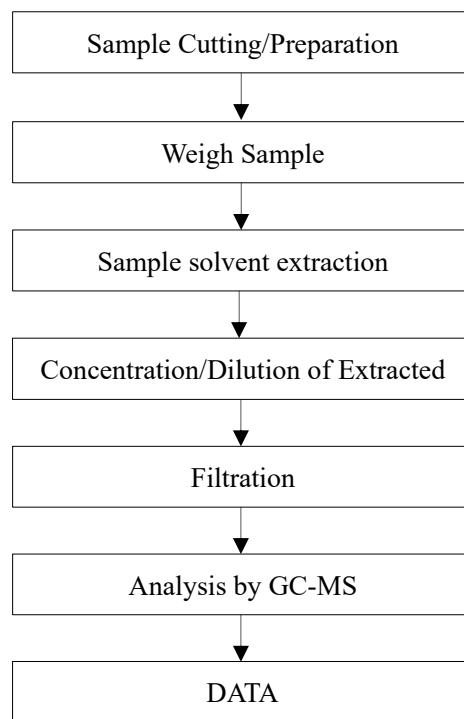
Test Flow Chart of Heavy Metal Content**Test Flow Chart of Phthalates**
