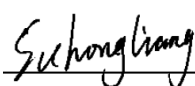

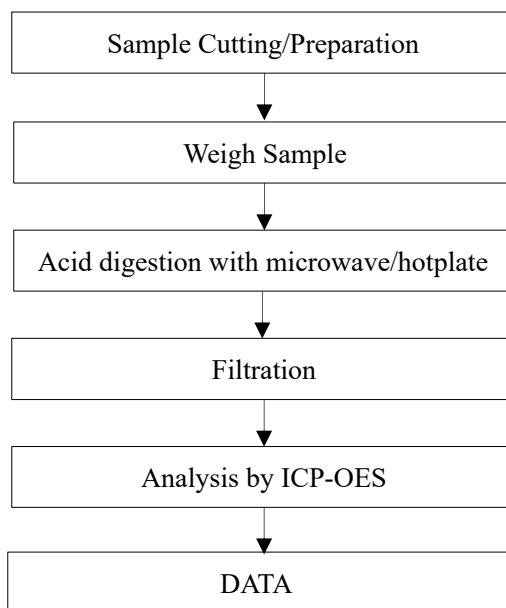

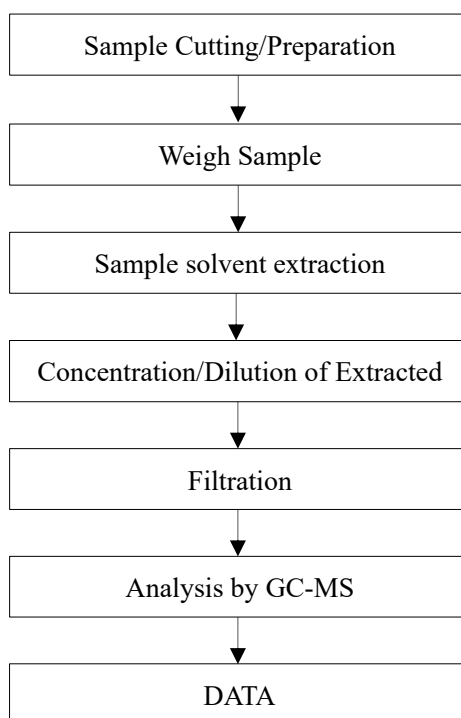

Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)



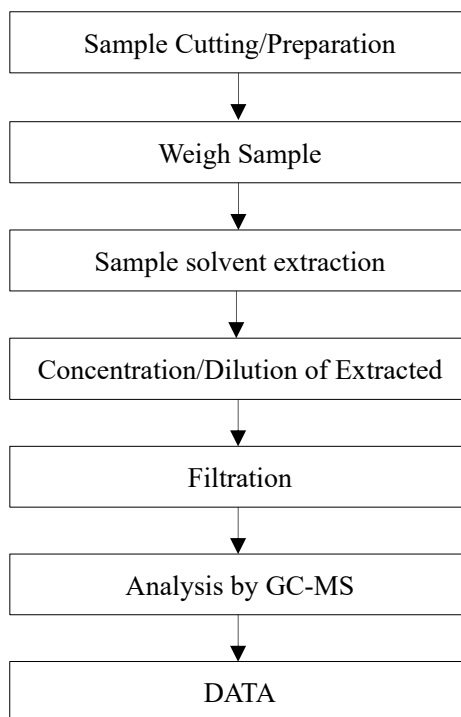
