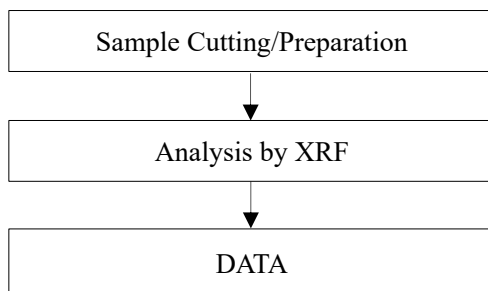

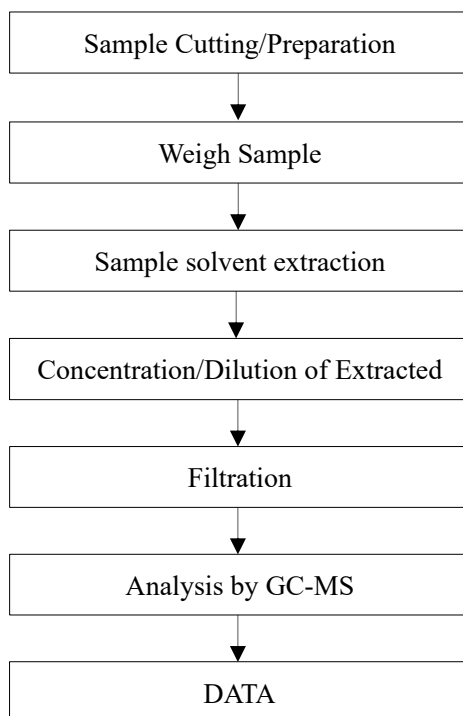

Test Flow Chart of Phthalates



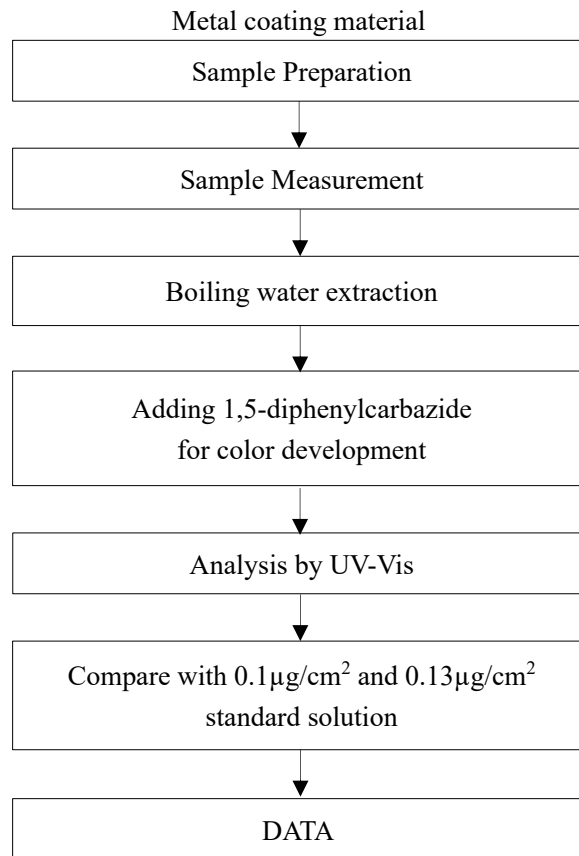

Test Flow Chart of Hexavalent Chromium (Cr^{6+})

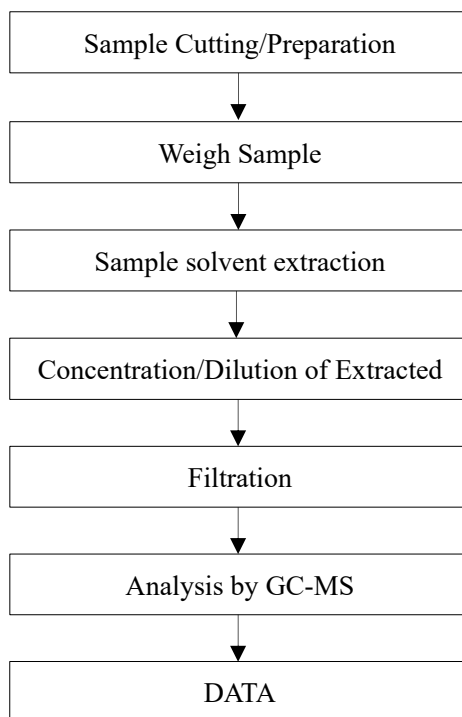
