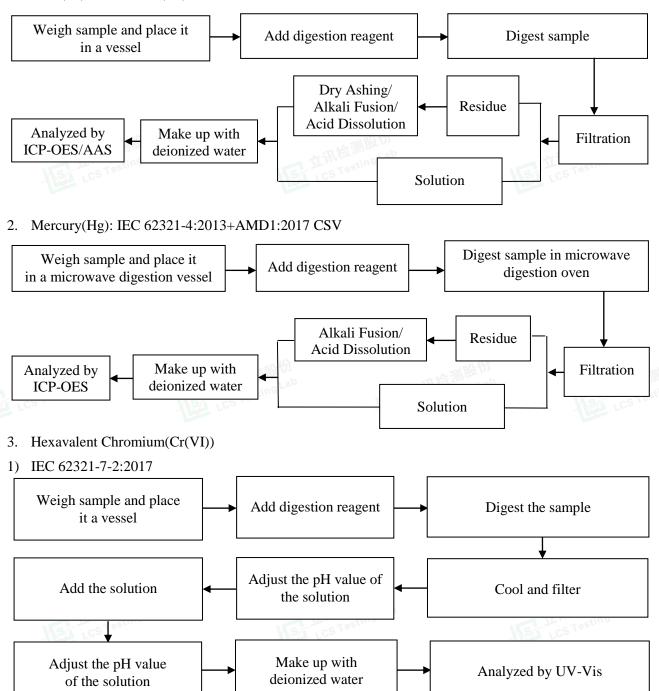

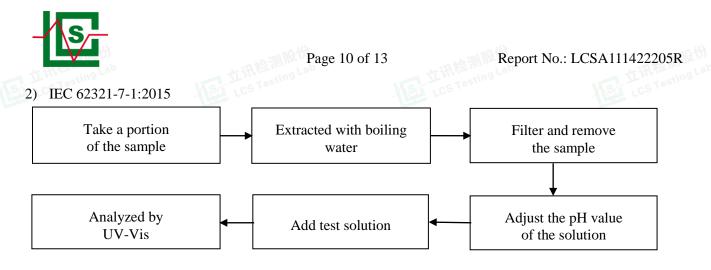

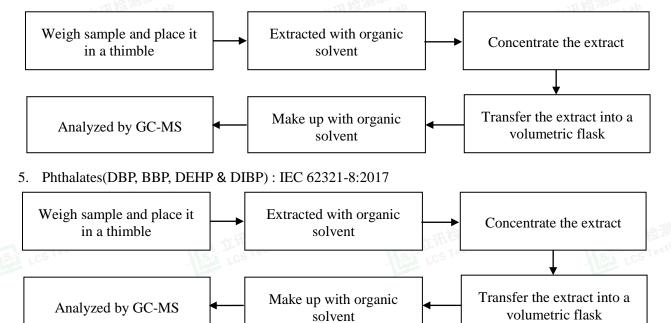
1. Lead(Pb) & Cadmium(Cd): IEC 62321-5:2013

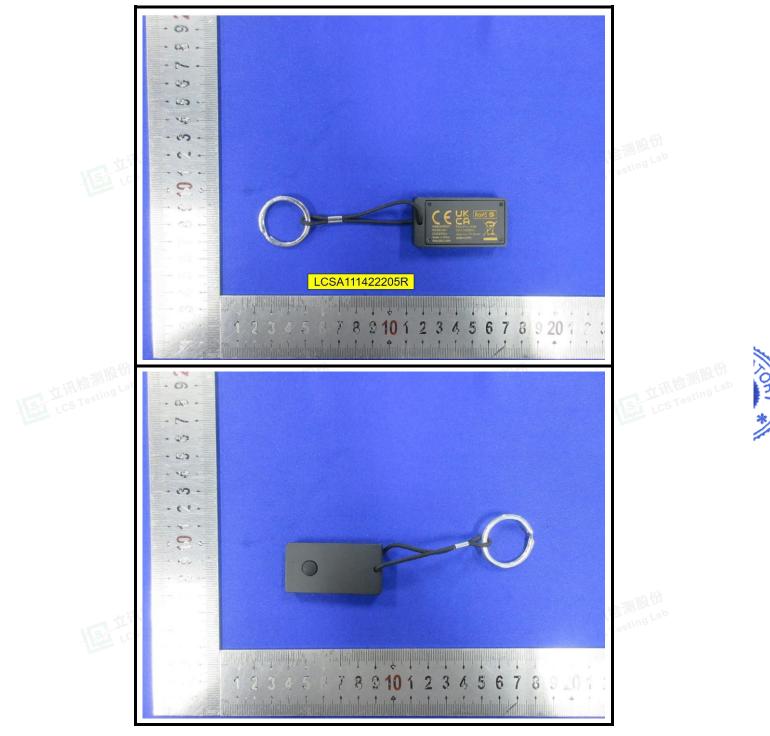

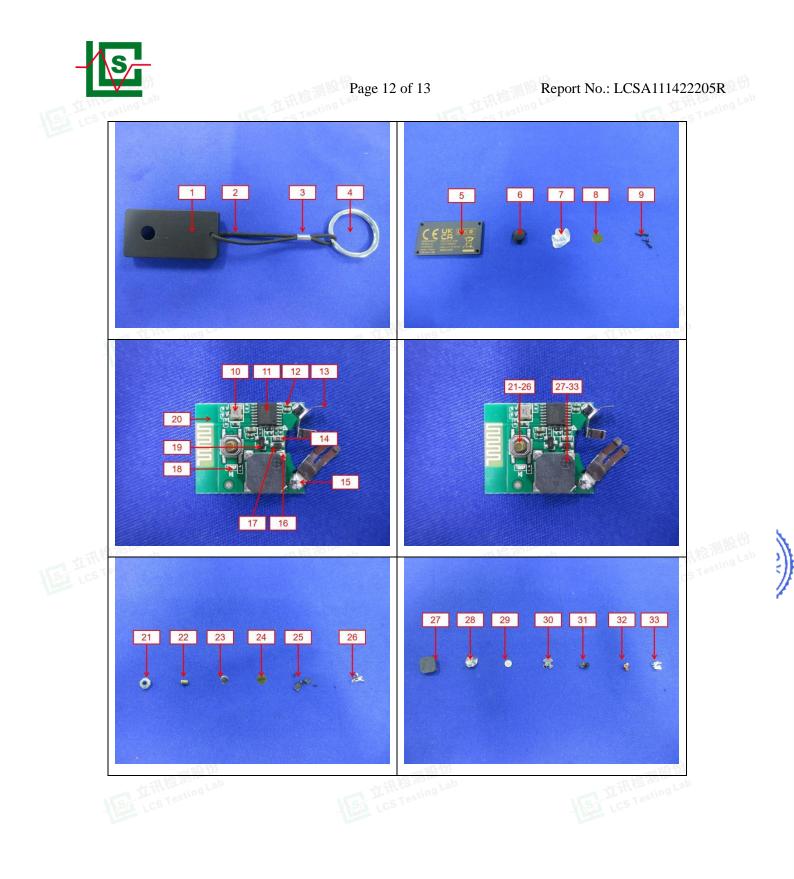
